1. <u>**CER Mission**</u> - The Voorhees Community Education Recreation program is provided by the Voorhees Board of Education to enrich the lives of the communities' families by using the resources at hand to meet the many and varied needs of the people living here. Our SAC program does that by providing quality childcare to residents in a familiar and safe environment. Our staff uses walkie-talkies between inside/outside staff, escorts children to and from the bathroom, and is very aware and protective of the security of your child.

2. <u>**Overview**</u> - The School Age Care childcare program in Voorhees Township has existed for over 50 years. We were one of the pilot programs in Southern New Jersey, and our program has served as a model for many other townships.

The CER philosophy is that every child is an individual. Every child is an essential little person and showing that to each participant is our goal while providing a safe, child-friendly atmosphere.

3. <u>Hours of Operation</u> - The childcare program is available from 7:00 – 9:00 AM and 3:30 - 5:30 PM at each elementary school every day when school is open. We always follow the school calendar. On half days of school, we begin our program at the conclusion of the school day. <u>SAC is held at each of the elementary schools</u>. Families that pick up past 5:30 will be charged a late fee of \$20.00 for each 15 minutes. Chronic late pick-up will result in termination from the program.

4. **<u>Registration/FOB Information</u>** - All children must be pre-registered online. There is a **NON-REFUNDABLE** registration fee of \$35.00 per child and a \$25.00 Annual Security Fee per family. Security fee provides all families with (2) activated key FOBs. FOBs will be activated for returning families once the fee is received. A third FOB may be purchased at an additional cost of \$25.00. Children <u>MAY NOT</u> start in this program without their parent/guardian completing this process. Parents must keep their children's forms up to date by promptly reporting any information changes.

5. <u>Children's Schedule</u> - When you register for the program, you will be asked to provide your child's schedule of attendance in the Childcare Program. If your child is NOT attending childcare on a regularly scheduled day (a dentist appointment, etc.), it is essential that you send in TWO NOTES in the morning - one to your child's teacher and one to the CER site supervisor. DO NOT CALL THE SCHOOL OR THE CER OFFICE. THE NOTICE MUST BE IN WRITING. If your child is absent from school, there is no need to call the CER office; we receive the school's daily attendance reports.

6. <u>**Transportation</u>** - TRANSPORTATION TO OR FROM THE CHILDCARE PROGRAM IS NOT PROVIDED BY CER OR THE BOARD OF EDUCATION. Transportation is the responsibility of the parent/guardian.</u>

7. <u>Administration of Medicines</u> - Our staff can only administer medicine according to BOE policy.

8. <u>Sick Children</u> - If your child is ill, they do **NOT** belong in school or CER Childcare. If your child gets sick while in childcare, you must come and pick them up.

9. <u>Sign In/Sign Out Procedures</u> - You MUST come into the school and sign your child in daily.

## Second, Child Rates calculated the same as above x \$5.75/hr.

- Each additional full-time student costs \$4140.00 a year.
- Each additional 3-day week student costs \$2415.00 per year.
- Each additional a.m. or p.m. student costs \$2070.00 a year.
- Each additional "Five days/month" costs \$1150.00 per year.

#### \*\*Please Note\*\*

No refunds for missed days. SAC hours 7-9 a.m. and 3:30-5:30 p.m. Registrations will be "First Come – First Serve." All current families must re-register for the 2025-2026 School Year Registration for 2025-2026 School Age Care will open on August 4, 2025 Once the program is closed, all additional families will be placed on a "Wait List."

- September charges are due on September 1, 2025. All remaining payments are due on the 15<sup>th</sup> of each month.
- Families falling 14 days past due will be terminated, and a vacated spot will be offered to the next family on the waiting list.
- Any family not utilizing their scheduled time must send (2) notes as usual.

11. <u>Billing Procedure</u> - You will receive your bill via (e-mail and postal service) at the beginning of each month. The deadline for payment will be the 15th of each month, starting on October 15<sup>th</sup>. September nonrefundable tuition is due at the time of registration, along with a nonrefundable registration fee and security fee. Payments can be mailed to the CER office, Attn: SAC Payment, 1000 Holly Oak Drive, Voorhees, NJ 08043, or made online using the "My ProCare" parent portal. Families will receive instructions on how to open their accounts after they have been accepted into the program.

Prompt payment is essential. CER is self-funded and does not receive tax dollars for staffing and supplies. Your payments are what keep this program in operation. Parents/guardians who have not paid outstanding bills by the second month will jeopardize their family's privilege to use our program. Failure to pay sums due the CER office by the 15<sup>th</sup> of the month will result in the additional imposition of a late fee of \$40, together with an amount equal to the attorney's fees, costs, and expenses incurred by the Voorhees Township Board of Education in seeking to collect same. If your account is in arrears over 15 days, your child/children will be excluded from using the SAC Program. <u>Once an account is designated for collection, all future use of SAC will be permanently terminated</u>.

12. <u>Discipline Procedure</u> - The school's discipline code is in effect during the SAC program and can be found in your child's handbook. Children who do not cooperate or follow instructions will be spoken to by staff. If the child must be spoken to consistently, the parent will also be made aware of the situation. In severe discipline cases, the parents will be called and asked to pick their child up immediately. If behavior is not significantly improved, the parents will be notified of possible suspension or exclusion from the program. Participation in the CER School Age Childcare Program is a privilege, not a right. This privilege can be revoked due to continued misbehavior or failure to follow the procedures in this Parent Manual.

13. Once a parent comes to the school to pick up your child, you must take the child promptly, not leave, and return later if the child wishes to stay.

15. <u>Snow Days/School Closing/Delayed Opening</u> - When inclement weather is severe enough to cause the closing of schools for the entire day, the district will release announcements regarding these closings.

- When school is canceled, there is **NO** childcare.
- If school is closed early due to inclement weather, **CER School Age Care will be** canceled.
- On days when the weather causes a 2-hour delay, SAC will begin at 9:00 am.
